In establishing a committee to explore the possibilities and implications of a Faculty Council, Trevor Sharp and I have tentatively agreed to form a committee of

You will note that I have purposely gone to faculty who are relatively new to the campus in hopes that they will have fewer preconceived notions on previous organizations. These suggested faculty appointments have not yet been approved by -- or suggested to -- the Committee on Committees.

Below is a draft of a statement to the persons whom we would ask to consider committee membership:

President Drushal has mentioned to various groups the possibility of establishing a group composed of students, faculty, and administrators to assume certain duties and responsibilities now assigned to the SFRC, SGA, Faculty, Administration and possibly other groups.

When the Lowry Center opens many of the duties and responsibilities assigned to the SGA, Lecture Committee and other organizations, will be under the direction of the Lowry Center Board. Thus it seems all the more appropriate at this time for us to consider establishing such a student-faculty-administration committee.

Trevor Sharp and F. W. Cropp, co-chairmen of the SFRC, have been asked by SFRC to organize a committee to study the implications of a student-faculty-administration group which would recognize the new structure of campus social activities and suggest a different framework for College decision-making and policy formulation.

The committee will be composed of 6 students, 4 faculty members, and 4 administrators.
